WEIGHT LIMITS: Moved by Inman and seconded by Hardwick to approve the following resolution and authorize the Chairman to sign the resolution and a letter to the Highway Patrol. All voted aye. Motion passed.

HUGHES COUNTY RESOLUTION NO. 2018 – 2 WEIGHT LIMIT ENFORCEMENT

WHEREAS, seasonal climatic changes can be detrimental to our highways, and WHEREAS, the Hughes County Board of County Commissioners, desires to protect existing Hughes County Highways, ultimately saving tax dollars and,

WHEREAS, the Hughes County Board of County Commissioners, desire the enforcement of weight limitations on Hughes County roads as set forth and posted by the Hughes County Highway Superintendent.

NOW THEREFORE BE IT RESOLVED;

WHEREAS the limits on Hughes County highways shall be set at seven (7) ton per axle on all asphalt surface roads and six (6) ton per axle on all blotter and gravel roads during spring

thaw period and when limit signs are in place. That the South Dakota Highway Patrol be and hereby is authorized and requested to enforce weight limitations on Hughes County roads.

BE IT FURTHER RESOLVED that the penalty for the violation of the load restrictions shall be as set forth in SDCL 32-22-55.
