Chairman Norm Weaver called the Monday June 18, 2018 meeting of the Hughes County Board of Commissioners to order at 5:30 PM with members Roger Inman, Tom Tveit, and Bill M. Abernathy present. Commissioner Jim Hardwick was absent. Planning and Zoning Director Eric Booth was also present. The meeting began with a prayer by Pastor John Fette and the Pledge of Allegiance.

AGENDA: Moved by Abernathy and seconded by Inman to approve the agenda. All voted aye. Motion passed.

MINUTES: Moved by Tveit and seconded by Inman to approve the minutes of the June 7, 2018 Commission meeting. All voted aye. Motion passed.

PUBLIC COMMENT: John Gruenwalt suggested more training for snowplow drivers. Mark Rilling asked about the proposed road maintenance fee and what the assessment would cost. John Barber asked how commissioners plan to make the assessment be fair and equal. Cindy Arch commented on the condition of Dry Run Road today. Jim Carpenter suggested having a plan for using the fund for regular maintenance on these roads. Mark Rilling asked about maintaining it as a road district, instead of the special assessment.

FINAL CONSIDERTION: PLAT OF LOT 1 MYRIL'S ADDITION: Cindy Arch was present to answer any questions. Nobody appeared to testify. Moved by Abernathy and seconded by Tveit to approve Resolution 2018-05 a plat of Lot 1 Myriløs Addition in the SW less E1/2 NE NW SW Sec 3 110-78. All voted aye. Motion passed.

FIRST READING: SUBDIVSION ROAD MAINTENANCE FEE ORDINANCE: The following subdivisions have secondary roads maintained by Hughes County at no cost to the lot owners: Oahe Acres- roads included are Merry, Sleigh, Dove, Blackbird, Quail, Grouse, Bluejay, and Grey Goose Road; Hyde Subdivision ó roads included Hyde, Meadowlark, Holly and Grey Goose Road; North Forty Addition-roads included Holly, Stewart and McCabe; Sunshine Acres-roads included Sunshine Loop and Hwy 1804; Dell Acres-roads included Corral, Sage and Redwood; Camelot-roads included Lambeth, Essex, Kingsway, Oxford, Bond, Regent, Windsor, and Sussex; Lakeview Acres- roads included Lakeview Place and SD Highway 34; Canning-roads included Canning Road, North Canning Road, Spring Street, and Cactus Loop; and Spring Creek-roads include East Spring Creek Drive. This ordinance would assess a fee to each lot based on the front footage for the purpose of maintaining the roads.
