**PUBLIC HEARING: FIVE YEAR TRANSPOTATION PLAN:** Time set for 5:35 PM to consider public testimony for the County Road & Bridge Five Year Transportation Plan. Nobody appeared to testify. Moved by Inman and seconded by Abernathy to approve and authorize the chairman to sign the Road & Bridge Five Year Transportation Plan. All voted aye. Motion passed.

**EMERGENCY MANAGEMENT STATE & LOCAL AGREEMENT:** The office of Emergency Management is awarding Hughes County funding to be used for salary costs related to the operation of the emergency management organization during 2019. Moved by Abernathy and seconded by Tveit to accept and authorize the Chairman to sign this agreement. All voted aye. Motion passed.

LOCAL EMERGENCY OPERATIONS PLAN (LEOP) and mitigation plan update is being reviewed.

## **EMERGENCY MANAGEMENT HOMELAND SECURITY GRANT:**

Emergency Director Rob Fines reviewed the process for the Homeland Security Grant for approximately \$250,000 to be used to purchase radios for fourteen counties. Over the next 5 years we expect to receive funds to replace all the radios prior to the P25 conversion. Hughes County will receive the grant money, purchase the radios, and then transfer them to the other counties.

**PUBLIC HEARING: MALT BEVERAGE LICENSE TRANSFER:** Time set for 5:45 PM to consider the transfer of a Malt Beverage license from Triple M Travel Plaza to 1 Stop Travel Plaza. Prakash Saripalli with 1 Stop Travel Plaza attended. Nobody appeared to testify. Moved by Inman and seconded by Abernathy to approve transferring the Malt Beverage license from Triple M Travel Plaza to 1 Stop Travel Plaza. All voted aye. Motion passed.

**PUBLIC COMMENT:** Bill Johnston appeared before the commission suggesting increased setbacks for Industrial wind turbines in Hughes County. He believes current ordinances do not adequately protect non participating property owners.

**PERSONNEL:** Moved by Hardwick and seconded by Inman to approve hiring Kody Hall, Deputy Sheriff at Pay Grade 16 Step Min \$19.69 per hour starting September 18, 2018. All voted aye. Motion passed.

Moved by Abernathy and seconded by Hardwick to approve hiring Dustin Drew, Deputy Sheriff at Pay Grade 16 Step 2 \$21.20 per hour starting September 18, 2018. All voted aye. Motion passed.

Moved by Tveit and seconded by Abernathy to approve hiring Nicole Hofeldt, Jail Nurse at Pay Grade 20 Step 7 \$67,859 annually starting on October 22, 2018. All voted aye. Motion passed.

**2019 BUDGET:** Moved by Tveit and seconded by Abernathy to increase the EMS budget by \$252,481 (\$2,600 for salaries and \$249,881 for equipment), and increasing the Revenue Budget for EMS by 249,881 for EMS Grant Revenue and increasing the General Property tax revenue by \$108,330. All voted aye. Motion passed.

Moved by Inman and seconded by Hardwick to approve and authorize the 2019 budget. All voted aye. Motion passed.
