Abernathy and Connie Hohn was present via phone. County Manager Kevin Hipple was also present. The meeting began with a prayer by Pastor John Fette and the Pledge of Allegiance.

AGENDA: Moved by Abernathy and seconded by Weaver to approve the agenda removing the executive session. All voted aye by roll call vote. Motion passed.

MINUTES: Moved by Inman and seconded by Abernathy to approve the minutes of the November 5, 2020 Commission meeting. All voted aye by roll call vote. Motion passed.

NEW FACILTIY DISCUSSION: No action taken.

SPRING CREEK COW CREEK SANITARY ASSET TRANSFER AGREEMENT: Moved by Inman and seconded by Weaver to transfer \$10,000 to the Spring Creek Cow Creek Sanitary District. All voted aye by roll call vote. Motions passed.
