Chairman Randy Vance called the Monday, February 1, 2021 meeting of the Hughes County Board of Commissioners to order at 5:30 PM with members Tom Rounds, Randy Brown, Bill Abernathy and Connie Hohn. County Manager Kevin Hipple, Planning Director/ Building Official Eric Booth, Sheriff Darin Johnson, Emergency Manager Rob Fines, and Highway Superintendent Rob Brunmeier were also present. The meeting began with a prayer by Pastor John Fette and the Pledge of Allegiance.

AGENDA: Moved by Abernathy and seconded by Hohn to approve the agenda. All voted aye. Motion passed.

MINUTES: Moved by Hohn and seconded by Abernathy to approve the minutes of the January 19, 2021 Commission meeting. All voted aye. Motion passed.

PUBLIC HEARING: MENTELE APPROACH VARIANCE - 117 LINNELL ST: Time set for 5:30 pm for a public hearing. Don & Karen Mentele are requesting a variance permit for an approach for their home at 117 Linnell St. Menteleøs explained the need for the approach to access their garage easier and safer. Also, four propane tanks are serviced on this approach. There is also a utility box located nearby which would limit where you could located an approach. Menteles indicated they had followed the proper process and requested and received an approach permit prior to starting construction. They contend it was the Countyøs error in issuing the permit, not their error.

Staff reported that they had received the following public comment prior to the meeting; one letter in opposition, one phone call in opposition and one phone call in favor, one email in opposition and one email in favor. Details of those comments were shared with the Commission and included in their packets.

Kathleen Schuh shared an estimate of \$783.60 from CenturyLink to move the utility box located near their approach at 118 Linnell Street.

Bruce Petersen asked why this ordinance is in place, saying the new approach is much safer than the previous approach.

Darrel Beck brought up the speed limit is reduced to 35 mph and since its lower more approaches should be allowed.

No in person opponent testimony was offered. The public hearing closed.

The commission requested Menteleøs to meet with the neighbor (Schuhøs) to combine their two approaches into one shared approach and bring it back to the commission.

Moved by Rounds and seconded by Abernathy to postpone the variance until Menteleøs bring a proposal. All voted aye. Motion passed.

FEMA BRIC GRANT: Jordan Lamb, GM Oahe Electric Cooperative is requesting support for the Building Resilient Infrastructure and Communities (BRIC) Grant to help with the cost of burying power lines. Jim Poppen, Mitigation and Recovery Manager for the State of SD and Matt Eldridge, Operations Manager for Oahe Electric were present to answer questions. This would be a pass through grant for up to \$600,000 and bury approximately 5 1/2 miles of lines. Oahe Electric would be responsible for any costs associated with an audit triggered by the grant. Moved by Rounds and seconded by Abernathy to approve moving forward with the FEMA BRIC Grant as a pass through grant for Oahe Electric Cooperative. All voted aye. Motion passed.
