# COMMISSIONER PROCEEDINGS HUGHES COUNTY, SOUTH DAKOTA

Chairman Randy Brown called the Monday, May 2, 2022 meeting of the Hughes County Board of Commissioners to order at 5:30 PM with members Tom Rounds, Connie Hohn, Bill Abernathy, and Randy Vance present. County Manager Kevin Hipple, Sheriff Patrick Callahan, Director of Planning and Zoning Eric Booth, Highway Superintendent Trent Arbach, States Attorney Jessica LaMie, Director of Equalization Melissa Flottmeyer, and Veterans Service Officer Janet Beck were also present. The meeting began with a prayer by Pastor John Fette and the Pledge of Allegiance.

**AGENDA:** Moved by Abernathy and seconded by Vance to approve the agenda. All voted Aye. Motion passed.

**CONFLICT OF INTEREST:** Bill Abernathy stated that he may have a conflict with the plat involving the Capitol Welding Addition. Randy Vance stated he may have a conflict with personnel.

**MINUTES:** Moved by Hohn and seconded by Vance to approve the minutes of the April 18, 2022 Commission meeting and the April 18, 2022 County and Consolidated Boards of Equalization. All voted Aye. Motion passed.

**STATES ATTORNEY UPDATE:** States Attorney Jessica LaMie reviewed the report with the Commission.

**PROPERTY TAX ABATEMENT:** Moved by Hohn and seconded by Abernathy to approve the abatement of the 2021 taxes payable in 2022 for Deborah Wagner at 1603 E Capitol Ave.; Wells Second Addition Block 35 Lots 27 & 28. The property qualifies for an Assessment Freeze. This would abate \$54.92 and refund \$54.92. All voted Aye. Motion passed.

**EQUALIZATION UPDATE:** Director of Equalization Melissa Flottmeyer reviewed the report with the Commission.

**VETERANS SERVICE UPDATE:** Veterans Service Officer Janet Beck reviewed the report with the Commission.

**JOINT POWERS AGREEMENT FOR RUMBLE STRIP PROJECT:** Dustin Witt from SD DOT explained the proposal. There was discussion on the impacts of on bicyclists. Moved by Abernathy and seconded by Vance to approve the agreement with SD DOT to install rumble strips along the edge of the pavement on a five mile stretch of Grey Goose Road. 100% of the funding will come from State safety funds and Hughes County's only responsibility will be to maintain the rumble strips, pavement markings, and signs associated with the project. Abernathy, Hohn, Brown & Vance voted Aye. Rounds voted Nay. Motion passed.

**CONSIDER ROAD STRIPING AGREEMENT:** Moved by Vance and seconded by Rounds to approve the agreement between Hughes County and the State DOT for project number P 000S(00)233, PCN 07DP, and authorize the Chairman to sign all related documents.

**CONSIDER BRIDGE BIDS:** Moved by Rounds and seconded by Abernathy to approve the bid received from Midwest Contracting, Marshall, MN for \$436,916 for project number BRO 8033(00)19-1, PCN 078J, for a bridge on 324<sup>th</sup> Ave and authorize the Chairman to sign all related documents.

### **PLANNING & ZONING:**

**FIRST CONSIDERATION: PLAT OF LOTS 2R & 3, CAPITAL WELDING ADDITION NE NE SEC 11 & SE SE SEC 2 110-79:** Cody & Kelly Geffre, owners of Lot 3, are proposing to replat two lots to square up a lot line in the middle of the two lots. Geffre's would like to build a storage unit on the lot. The final consideration will be held at the May 16, 2022 at a joint County/City Commission meeting at the Courthouse.

**FIRST READING: MCARTY TRACT 1 PLAT & REZONE TO PUD NW SEC 25 112-80:** Paul McCarty would like to rezone approximately 96.54 acres that includes the N1/2 NW1/4 less HWY ROW and the portion of N1/2 SE1/4 NW1/4 that is McCarty Tract 1, Section 25 112-80 to PUD with Ag B rules and plat McCarty Tract 1. The public hearing and final consideration will be held at the May 16, 2022 County Commission meeting at the Courthouse at 5:30 pm.

**FIRST READING: TRACT 1 LAKE SHARPE SUBSTATION ADDITION PLAT & REZONE TO PUD SE NE SEC 4 109-75:** Etzkorn Family Land Limited Partnership along with Paul Letsche, representing East River Electric Cooperative Inc. have petitioned for rezoning to PUD in order to plat a smaller than 35 acre parcel for the construction and operation of an electrical substation. This new plat will create Tract 1 of Lake Sharpe Substation Addition, a 3.28 acre parcel that will be the site of a new electrical substation. The public hearing and final consideration will be held at the May 16, 2022 County Commission meeting at the Courthouse at 5:35 pm.

**ADVANCED CORRECTIONAL HEALTHCARE CONTRACT AGREEMENT:** Moved by Hohn and seconded Vance by to approve the amendment to the contract between Hughes County and Advanced Correctional Healthcare for healthcare for prisoners at the jail. The change will reduce nursing hours and increase mental health care hours. All voted Aye. Motion passed.
