REDING BRIDGE GEOTEXTILE FABRIC CHANGE ORDER PNC08X7: Anderson Contractors have excavated the Reding Bridge down just below the required depth, but had encountered quite a bit of water. The site is too wet to allow them to pour the footings for the bridge. There is ground water constantly infiltrating into the site. They have several pumps running continuously in an effort to dewater the site, but the pumps are unable to keep up. Anderson Contractors propose to install a geotextile fabric to stabilize the site before they begin to install the gravel which goes under the bridge foundation. Brosz Engineering has reviewed the proposal and concurs with the contractor's recommendations. The additional cost from Anderson's to install the fabric would be \$15,984.22. The change would require a time extension for installing the fabric. The specific amount of time will be worked out between the contractor, Brosz Engineering and Hughes County. The current completion deadline is around the second week of November. This change will likely push that back to around Thanksgiving. Kyle Kurth & Robert Williams appeared to give an update on the project to the Commission. Moved by Abernathy and seconded by Hohn to approve and authorize the Chairman to sign the change order for Structure Number 33-410-024 in the amount of \$15,984.22. All voted Aye. Motion passed.

**PURCHASE HWY DEPT GRADER MOUNTED SOD MULCHERS:** Moved by Rounds and seconded by Hohn to approve purchasing two newly rebuilt sod mulchers from Tisdale Saskatchewan Canada in the amount of \$59,000.00 for the Hughes County Highway Department. All voted Aye. Motion passed.
