Remove \$5,300 for Achievement Days; increase Judicial Budget \$2,000 for Teen Court; increase Sheriff Budget \$1,550 for work comp rates; increase Jail budget by \$13,800 by adding a new PREA Employees at \$40,800 and reducing the work comp by \$27,000; reduce the Juvenile Shelter budget by \$4,200 for work comp rates, and increase Road & Bridge Budget \$5,500 for work comp rates. All voted aye. Motion passed.

CONTINGENCY TRANSFER: Moved by Hardwick and seconded by Inman to approve the contingency transfer of \$13,042.80 to the Court Appointed Attorney Fund. After discussion, moved by Hardwick and seconded by Inman to amend the motion to \$40,000. All voted aye. Motion passed.
