Moved by Weaver and seconded by Inman to approve the proposal from Brosz Engineering to evaluate the facilities, programs and possible alternate sites for a new court facility not to exceed \$27,000 and begin work in January 2021 and complete the final report within six weeks. All voted aye. Motion passed.

PICTOMETERY AERIAL IMAGERY CONTRACT: Moved by Inman and seconded by Abernathy to table until January. Commissioners Inman, Weaver, Abernathy and Vance voted aye. Commissioner Hohn voted nay. Motion passed.

SURPLUS PROPERTY COW SPRING CREEK SANITARY SYSTEM: Moved by Weaver and seconded by Abernathy to approve the Cow/Spring Creek Sanitary System Surplus Resolution 2020-29. All voted aye. Motion passed.

WHEREAS Hughes County currently operates the Cow / Spring Creek Sanitary System, õthe Systemö, without express authority of South Dakota State Law; and

WHEREAS Hughes County faces the possibility of liability from potential issues which may arise in the operation of the System and has determined that it must discontinue operating the System; and

WHEREAS it appears that significant future expansion of the System will occur into Sully County, increasing the number of customers outside of Hughes County, and

WHEREAS Hughes County finds that property used for operating the System would no longer serve a public purpose insofar as Hughes County is involved, and

WHEREAS the Spring / Cow Creek Sanitary District has been approved by the voters and officially organized as a governmental subdivision and recognized by both Hughes and Sully Counties and recognized by the SD Secretary of State;

BE IT RESOLVED that the Board of Hughes County Commissioners declares as surplus property the entirety of the Cow/Spring Creek Sanitary System. That includes all of the water and sewer services

operated by Hughes County, to include the buildings, structures, water lines, water tanks, pumping stations, sewer lines, lift stations, wastewater treatment lagoons, and other system facilities.

That it is the intent of the Hughes County Commission to transfer the Cow/Spring Creek Sanitary System to the newly created Spring/ Cow Creek Sanitary District. Hughes County will work with the sanitary district to develop the necessary transfer documentation to legally transfer the entirety of the system and to transfer all necessary permits, licenses, easements and other associated documentation.

That this resolution replaces Surplus Resolution 2018-12, which dealt with the same topic.

COW SPRING CREEK SANITARY SYSTEM ASSET TRANSFER AGREEMENT: Moved by Inman and seconded by Weaver to approve and authorize the chairman to sign the Asset Transfer Agreement with Spring Creek/ Cow Creek Sanitary District and to set a closing date and sign whatever documents are necessary to complete the transfer. The official transfer date would be January 1, 2021. All of the assets of the system would be transferred, to include real property, all of the water and sewer services, to include the buildings, structures, water lines, water tanks, pumping stations, sewer lines, lift stations, wastewater treatment lagoons, and other system facilities. All of the funds in the accounts associated with the System will also be transferred, with a portion paid at closing and the remainder paid in February 2021 after the end of year bills are paid.
