## COMMISSIONER PROCEEDINGS HUGHES COUNTY, SOUTH DAKOTA

Chairman Randy Vance called the Monday March 15, 2021 meeting of the Hughes County Board of Commissioners to order at 5:30 PM with members Randy Brown, Bill M. Abernathy, Connie Hohn and Tom Rounds present. Pierre Mayor Steve Harding, Pierre City Commissioner Blake Barringer, Pierre City Commissioner Jamie Huizenga, City Administrator Kristi Honeywell, City Planner Sharon Pruess, County Manager Kevin Hipple, Director of Equalization Melissa Flottmeyer, Sheriff Darin Johnson, States Attorney Jessica LaMie, and Planning Director/ Building Official Eric Booth and were also present. The meeting began with a prayer by Pastor John Fette and the Pledge of Allegiance.

**AGENDA:** Moved by Abernathy and seconded by Hohn to approve the agenda removing the Purple Heart County Proclamation. All voted aye. Motion passed.

**MINUTES:** Moved by Hohn and seconded by Abernathy to approve the minutes of the March 1, 2021 Commission meeting. All voted aye. Motion passed.

**SPECIAL BUSINESS: JOINT COMMISSION: PLAT OF DRY RUN TRACT 3R IN S1/2 NE & GOVT LOT 6 SEC 7 110-78:** Dan & Sandra Mostellar are requesting to plat two lots into one lot to address nonconforming structures and setbacks, and construct an additional accessory structure. Moved by Pierre Mayor Harding and seconded by Commissioner Rounds to approve Resolution 2021-4 and City of Pierre Resolution #2690 the plat of Tract 3R in S1/2 NE & Govøt Lot 6 Sec 7 110-78. All voted aye. Motion passed.

Moved by Rounds and seconded by Hohn to approve the East River Electric Right of Way Occupancy Agreement for lines to serve the new substation on the Northeast corner of Range Rd and SD Highway 1804, and an agreement to repair any damage caused to the road during construction. The County and East River will do an inventory of the road before the project begins. All voted aye. Motion passed.
